# **3.2 ELIGIBILITY CRITERIA FOR B.ED:**

(a) A Candidate shall be eligible for the admission to two years Bachelor's Degree programme in Education [B.Ed.,(Non-semester)] provided that he/she should have passed the three year Bachelor's Degree programme under 11+1+3 or 10+2+3 pattern of study or five years integrated Master's Degree programme under 10+2+5 pattern of study and majored in any one of the subjects related to a school subject offered at the Secondary/Senior or higher secondary education level (OR) four years Bachelor's Degree programme in Engineering/Technology under 11+1+4 or 10+2+4 pattern of study (with Mathematics and Science in both higher secondary and Engineering programmes).

(b) Candidates appearing for final year/semester are also eligible to apply. However, the merit list will be drawn based on **the percentage of aggregate of Part-III marks of all the semesters/years of the qualifying degree**.

c) Candidates should have scored a minimum of 50% marks either in Part-III (Main + Allied) of the Bachelor's degree programme or in the Master's degree programme in the same subject of specialization (In case of OBC, BCM, MBC, EBC, SC, ST, BT and PwD, a candidate should have scored a minimum of 40% marks)

d) Candidates should have scored a minimum of 55% of marks in Bachelor's degree programme in Engineering/Technology. (In case of SC/ST candidates, the candidate should have scored a minimum of 50%marks).

e) A Candidate who has taken more than one school subject as Main (Double or Triple Major) in the Bachelor's Degree will be eligible for admission to only one of the school subjects chosen.

f) There is **No upper age limit** for admission to two year B. Ed., programme.

# **3.3 PROCEDURE FOR DETERMINING THE MERIT LIST AND TIE-BREAK:**

<u>Merit score</u>: The subject-wise merit list will be prepared based on **the percentage of** aggregate of Part-III marks of all the semesters/years of the qualifying degree.

<u>Order of Priority for Tie-Breaker</u>: In case the merit score is same for two or more candidates, the tie will be resolved by adopting the following two steps in the same order:

(a) Total marks of all the subjects of all the semesters/years of the qualifying degree will be compared.

(b) In case the total marks too results in a tie, it will be resolved using the date of birth. An earlier born candidate will be ranked higher.

# **4.3 PROCEDURE FOR DETERMINING THE MERIT LIST AND TIE-BREAK:**

<u>Merit Score:</u> Selection of Candidates for admission will be based on the total marks secured by the candidate in the H.Sc Exam or its equivalent (10 + 2).

**<u>Tie-Breaker</u>**: In case the merit score is same for two or more candidates, the tie will be resolved using the date of birth. An earlier born candidate will be ranked higher.

### 5. INSTURCTIONS TO CANDIDATES:

### 5.1 SUBMISSION OF APPLICATION:

i) The application for both B.Ed and D.El.Ed can be downloaded from the website <u>www.pkcekkl.in</u> from 25.07.2023 in PDF format. The duly filled in application along with the enclosures may be submitted to the Principal, PKCE, Karaikal on or before in person or by post (the College is not responsible for postal delay) as stated below along with a copy of challan of remittance of fee as mentioned hereunder in the <u>Ac/No.099601003129</u>, Bank - ICICI Bank, Karaikal Branch (IFSC Code: ICIC0000996) of this College towards <u>processing fee</u>(\* - Subject to revision/approval).

### ii) Before filling up the application, read the prospectus carefully.

- iii) Candidates wishes to apply for B.Ed / D.El.Ed should submit separate applications.
- iv) The self-attested copies of the following documents should be attached.
- a) Mark sheets 10<sup>th</sup>, 12<sup>th</sup>, UG Degree (All semesters/Years) and PG Degree(for the subjects Psychology, Sociology, Commerce and Philosophy)
- b) Degree / Diploma / provisional certificate
- c) Transfer certificate
- d) Nationality certificate,
- e) Residence certificate
- f) Community certificate
- g) Certificates for FF/ ESM/ PWD / MSP as applicable.
- h) Aadhaar Card.
- i) The original counterfoil of the pay in slip for remittance of processing fee.

The **originals certificates** shall be produced for verification at the time of admission and should be submitted in the college for getting Nominal roll from the Affiliating Body. The admission will be given only on submitting all the originals and the latest Nativity,

Residence and caste certificates in the prescribed form as issued by the Government of Puducherry.

v) Candidates who have appeared for supplementary / final semester should not wait for the results but should apply on or before the last date. However the candidates should submit a photocopy of the qualifying examination result within 7 days from the date of announcement of result.

vi) In order to guide the applicants help desks have been arranged in the College to help the students for submission of online applications or in any other mode.

vii) The candidates provisionally admitted to a programme, should submit the original documents for verification and the same shall be returned only after obtaining recognition from the Pondicherry University, Pondicherry or other affiliating bodies. Hence, the candidates are advised to take sufficient photocopies of the documents before submitting the originals for verification.

(**NOTE:** The Principal / the Duly constituted Admission Committee of PKCE has the full rights to accept or reject the application of a candidate at any stage for any reliable reasons thereof.)

### **5.2PROCEDURE FOR ADMISSION:**

i) After the last date for receipt of applications, a provisional/final Merit list will be published in the website of this College for both the programmes.

ii) Based on the final Merit list, a provisional allotment order will also be published in the website. The seat thus allocated will remain provisional until the approval of the affiliating body and the allotment of Nominal role.

iii) Candidates concerned may download the provisional allotment order and report before the Principal, Perunthalaivar Kamarajar College of Education on the date informed therein/date of admission.

# iv) The number of seats in this Institute is subject to variation in accordance with the approval/orders of the NCTE/ SCERT/affiliating body.

v) Enabling Provision: After admitting all the eligible candidates of a specified category, if seats remain vacant in that specified category, then such vacancies will be surrendered to the general category for admission.

Reservation of seats for different categories is as per the norms of the Govt. of Puducherry.

**Note**: Tamilnadu/Other State Candidates will be considered for admission under the General category if there are vacancies after admitting all the eligible U.T. of Puducherry candidates. The fee structure for other state candidates will be different from the U.T. of Puducherry candidates.

### **5.4 DEFINITION FOR CATEGORIES IN RESERVATION POLICY:**

<u>A) RESIDENT OF PUDUCHERRY</u>: An applicant is considered to be a Puducherry resident if he/she is an Indian National and satisfies at least one of the following criteria:

1) The candidate or whose parent (either Mother or Father or Both) or Guardian (in case of children who have lost both the parents) has been residing continuously in this Union Territory for at least five years preceding the date of application.

2) Those who have passed the SSLC / HSC or any other public examination and for that purpose had undergone academic studies continuously for 5 successive classes immediately preceding the qualifying examination (including the year of qualifying examination) in a recognized educational institution located in Pondicherry UT and having their residence in Pondicherry UT for 5 years continuously during that period. Mere stay in places such as residential hostel would not amount to residence.

3) Children of natives of U.T. of Puducherry who have declared any place in U.T. of Puducherry as their home town and so certified by their respective Heads of Office. Nativity Certificate in the prescribed format has to be enclosed. (G.O. Ms. No. 64 dated 25th May 2006).

4) a) Children whose parents are Central/ State Government Servants/ Defense Personnel/ Central Paramilitary Forces/ Employees of Public Sector Undertakings wholly or substantially owned either by the Central Government or by the Puducherry Administration posted and serving in U.T. of Puducherry for atleast a minimum continuous period of three years immediately prior to the last date of submission of application.

b) Children of the above said employees should have studied HSc of two years in any of the schools in the U.T. of Puducherry and should have passed the qualifying examinations (HSc) from the same school. (G.O.Ms. No. 04, Puducherry dated 09.02.2016 of the Chief Secretariat (Hr. & Tech. Edn.), Puducherry.

5. Children of Defence Personnel (DP) who were killed or disabled in action and children of Central Government Servants/ Pondicherry U.T. Government Servants/Defence Personnel/ Employees of Public Sector Undertaking wholly or substantially run either by the Central Government or by the Puducherry U.T. Administration who died while in the service in the Puducherry U.T.

6) French nationals residing in the Puducherry U.T. and covered by the terms of the "Treaty of Cession" shall be treated on par with the candidates who produce the prescribed Puducherry U.T. Residence Certificate. Such French Nationals will not be required to produce Residence Certificate; instead they should produce a "Certificate of Registration" issued for this purpose by the French Consulate at Puducherry. Children of these French Nationals shall not be considered for admission under the quota of non-resident.

All the above certificates will be scrutinized first by a committee appointed or the purpose before the final merit list is prepared.

**Note**:1. Candidates seeking admission under U.T. of Puducherry resident quota must furnish the Residence Certificate from Department of Revenue & Disaster Management, Puducherry and renewed from time to time.

2. Children of French Nationals under clause 6 above shall not be considered for admission under thequota of non-resident.

### B) SCHEDULE CASTE (SC) AND SCHEDULED TRIBE(ST):

**SCHEDULED CASTE(SC):** Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Caste under <u>"The Constitution (Puducherry)Scheduled Caste order 1964"</u>dt: 05/03/1964, read with the constitution (SC) orders (Second Amendment) Act 2002 (Central Act 2002) and should enclose the certificate issued recently by an officer of the Department of Revenue & Disaster Management, Puducherry not below the rank of Deputy Tahsildar.

**SCHEDULED TRIBE(ST):** Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Tribe under "the THE CONSTITUTION (PUDUCHERRY) SCHEDULED TRIBES ORDER, 2016" dated 22.12.2016 and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

### C) OBC/BCM/MBC/EBC/BT CANDIDATES:

Candidates claiming admission under these categories should enclose / produce the certificate issued recently by an officer of the Department of Revenue & Disaster Management, Puducherry not below the rank of Deputy Tahsildar.

### D) FREEDOM FIGHTER (FF):

Candidates claiming admission under these categories should be Children / Grand Children of Freedom Fighters and they should enclose the necessary certificate issued by the Officer-in-charge, Freedom Fighter Cell, Govt. of Puducherry.

### E) WARDS OF Ex-Servicemen (ESM):

Those who are registered as Ex-servicemen in the Department of Sainik Welfare (DSW), Government of Puducherry and have got an Ex-servicemen / Widow of Exservicemen identity card from DSW should enclose the necessary certificate issued by the Director, DSW, Puducherry.

### F) PERSONS WITH DISABLITIES:

A person with not less than 40% disability as certified by the Medical Authority / duly constituted Medical Board is to be considered for admission under this category and the order of priority is as follows.

### I) VISUALLY IMPAIRED:

Those who suffer from either of the following conditions

i) Total absence of sight.

ii) Visual activity not exceeding 6/6 or 20/200 (Snellen on the better eye with correcting lenses and

iii)Limitation of the field of vision subtending an angle of 20 deg or worse.

### II) HEARING IMPAIRED :

Those in whom, the sense of hearing is not functioning for the ordinary purpose of life. Generally a loss of hearing at 70 decibels or above at 500, 1000 or 2000 Hz frequencies will make residual non functional.

### III) ORTHOPAEDICALLY CHALLENGED :

Those who have physical defect or deformity which causes an interference with the normal functioning of bones, muscles and joints.

### **G)MERITORIOUS SPORTS PERSON :**

To ensure that only sports persons of excellent caliber and those who have showed consistency in sports activities get benefitted under the Sports quota seats, the procedure given below will be followed.

### **1. ORDER OF PRIORITY:**

The selection of candidates under Sports Quota will be considered in the order of priorities given below.

- 1) Medal Winners / Rank holders in International Events
- 2) Participants in international events
- 3) National Level Medal Winners
  - a) Senior Level Medal winners in National Events
  - b) Junior Level medal winners in National Events
  - c) Sub junior level medal winners in National events
- 4) State level (Inter Schools) medal winners in sports of Education Department
- 5) Participation in a) National Level b) State Level.

### 2. ORDER OF SELECTION UNDER MSP:

- 1) Participation in National/State level sports must be accompanied with evidence to show that they have been taking active part in sports consistently
- 2) For those who have participated in more than one discipline of sports, consideration will be given only to the highest priority attained as given above
- 3) Only those who have taken part in the sports events organized by Govt. and Federations recognized by the Sports Authority of India will be considered.
- 4) In case of tie, consideration will be given to consistent / regular participation
- 5) Any further tie will be decided by taking into account of the marks obtained in the qualifying examination
- **6)** The final authority to settle all disputes in selection under sports quota will be the Member Secretary, PONSHE/ Director of Higher & Technical Education or any authority appointed especially for this purpose.
